Auctioneer keen to make his mark at Bonhams

THE battle for business in the struggling art auction market is set to intensify with the appointment of one of the country's best auctioneers, Mark Fraser, as the new chairman of the Australian arm of UK firm Bonhams.

Mr Fraser begins as chairman on Monday and yesterday vowed to make Bonhams the number one auction house in Australia.

"Without question, I am confident it can be. I am very fired up after time spent in London at Bonhams' head office," he said.

With Fraser in tow, Bonhams

will go head to head with local players Sotheby's Australia, Deutscher and Hackett, and current market leader, Menzies Art Brands, in what promises to be a tough and competitive auction year. Formidable businessman Rod Menzies, who owns Menzies Art Brands, had also tried to entice Fraser to join his firm, without success.

Bonhams' appeal was its intelligent and refined approach — it didn't simply treat art as a commodity, Fraser said. Its London specialists, and UK chairman Rupert Brooks, showed true passion for art objects and collectibles.

"It was so encouraging walk-

ing around from department to department [in London] and meeting people who are really excited by the objects they are handling . . . We are not there simply to churn the market, we are there to develop long-term collectors and connoisseurship, and that's something I have missed as an auctioneer."

Fraser said it was a difficult decision to leave MONA. "It was an incredibly addictive world that David Walsh created . . . I loved MONA, a baby I helped bring into the world. I miss it.'

He predicts that the coming year will continue to provide bargains for Australian art collectors. "The Australian market maybe grew a little too fast from 2005 to 2007 and there is certainly a return to reality and stability," Fraser said.
